## ABOUT THE INSTITUTE

Established in 1954-55 by the Agriculture Credit Department of the Reserve Bank of India, Deep Narayan Singh-Regional Institute of Cooperative Management (DNS-RICM), Patna stands as a premier residential institution dedicated to cooperative management education and training in India. The Institute operates under the aegis of the National Council for Cooperative Training (NCCT), New Delhi, and is fully financed and promoted by the Ministry of Cooperation, Govt. of India.

Over the years, the Institute has evolved in both scope and stature. A significant milestone was achieved in October 1997, when it was elevated to the status of a Regional Institute of Cooperative Management, enabling it to broaden its academic outreach, diversify its training portfolio and strengthen its role in capacity building research, consultancy, education and training for the all sectors of economy.

The Institute primarily caters to the research, consultancy, education, and training needs of personnel

from the cooperative, rural development, agriculture, and allied sectors in Bihar and Jharkhand. ## ABOUT MBA/BBA PROGRAMME

Our two-year, full-time MBA in Agribusiness and four years BBA (Agribusiness) programme, affiliated with *Tribhuvan Sahkari University (an Institution of National Importance established by an Act of Parliament under the Ministry of Cooperation, Government of India)*, is designed to develop professionals capable of leading, managing, and innovating in the agribusiness sector. Guided by its vision to create an ethos of creativity and innovation for enhancing the quality of management in the



agribusiness and rural sectors for the sustainable development of the overall economy, the programme is committed to its mission of fostering agricultural and rural prosperity through the effective management of agri-resources, thereby improving the quality of rural life. In line with this, the programme aims to create professionally trained agribusiness leaders with strong values and ethical grounding, develop professional attitudes and problem-solving skills to effectively serve all stakeholders in the agribusiness ecosystem, and encourage entrepreneurship, capacity building, institutional linkages, and meaningful contributions to policy development. . The curriculum blends core management fundamentals with sector-specific insights and includes a mix of core and elective courses, a summer internship, and hands-on project work, enabling students to thrive in a dynamic and evolving industry. The normal duration of the MBA (Agribusiness) programme is two academic years, comprising four semesters and for BBA (Agribusiness) programme is four academic years, comprising eight semesters.

### CURRICULUM DESIGN

A holistic approach has been adopted in framing the MBA Programs. The degree requirement consists of the compulsory core package, the elective package, the industrial attachment, and project.

#### **Course Outcome:**

The objective of the compulsory package is to (i) provide basic conceptual and analytical knowledge and inculcate aptitude and skills necessary for managerial effectiveness, and Foundation course in Agriculture.(ii) develop an integrated view of organizational and managerial functioning and understanding of the interdependency of sub-systems of business sector, (iii) create awareness and understanding of environmental forces impinging on managerial behavior, and (iv) understand the functioning of business organizations.

#### **Elective Courses:**

The MBA (Agribusiness) program provides specialization in key functional areas such as Agriculture, Agricultural Marketing, Human Resource Management, Finance, Information Technology etc. In

addition, the program offers industry-oriented specialization in Farm Engineering, Food Industry, Hi-tech Agriculture, Horticulture Industry, Food Retail & Supply Chain, Input Supply, and Livestock Industry, which constitute the unique strength of the MBA program.

The BBA (Agribusiness) program is designed to build a strong foundation in agribusiness management by integrating core business disciplines with practical exposure to the agriculture and allied sectors. The program equips students with managerial, entrepreneurial, and analytical skills required for emerging opportunities in agribusiness, agri-marketing, supply chain management, food processing, rural management, and allied industries.



### **Trainings/Summer Internship Programme:**

For ensuring exposure to working of a business organization to future managers, industrial attachment during summer is an essential academic requirement for the students. Each student has to spend summer break working in and learning from a business organization. The summer Internship/ Project Work provides the student first hand exposure to the functioning of the organization.

### **Pedagogy:**

At DNS-RICM, Patna, the teaching approach will be designed to seamlessly integrate conceptual learning with practical exposure. The Institute will adopt a mix of case-based learning to enhance analytical thinking and decision-making, along with experiential learning through field visits, on-going projects and Agri-rural internships. Classroom sessions will be highly interactive, incorporating simulations, role-plays, and problem-solving exercises that will encourage critical thinking and collaborative learning. The use of modern ICT tools, data analytics and business modelling techniques will strengthen digital proficiency and practical insight. This comprehensive and application-oriented pedagogy will aim to develop not only skilled managers but also responsible and innovative leaders capable of contributing effectively to the agribusiness sector.



### **Performance Evaluation System:**

The continuous performance evaluation system of the students, as an indicator of input utilization and conversion efficiency comprises class participation, case presentation group discussion, seminars, assignments, quizzes, and midterm examination, practical and final examination.

## ELIGIBILITY CRITERIA FOR MBA (AGRI-BUSINESS)

### **Educational Qualifications:**

Bachelor's degree in any discipline including four years B.SC (Agriculture) from recognized Universities with minimum 50% for General candidates and 45% for other Category. UG candidates who are waiting for the final result can also apply and upload a self-undertaking that he/she will furnish a certificate to institute at the time of the personal interview.

### **Selection Procedure:**

The candidate will have to appear in Common Admission Test (CAT) /Common Management Admission Test (CMAT) / Management Aptitude Test (MAT)/ Xavier Aptitude Test (XAT) 2025-26, and ICAR-2026 of conducted by respective agencies. RICM will use CAT/CMAT/MAT/XAT/ICAR score for short listing the candidates for its two years full time MBA programs. These short listed candidates will have to appear for further screening on the basis of Group Discussion and Personal Interview at DNS-RICM on specified date(s).

### **Number of Seats and reservation policy:**

The intake capacity for the MBA (Agribusiness) is sixty (60) only. Seats for OBC, SC and ST candidates are reserved as per the reservation policy of the Central Government. Candidates claiming reservation shall be required to submit appropriate certificate at the time of Personal Interview, failing which they shall be treated in general category only. Any subsequent claim for reservation shall not be entertained. Reservation of seats shall be as per the Policy of the Central Government. The Category (UR/EWS/BC/EBC/RCG/SC/ST) declared by the candidate in application form will be final. No subsequent change will be allowed.



## ELIGIBILITY CRITERIA FOR BBA (AGRI-BUSINESS)

### **Educational Qualifications:**

10+2/Intermediate/I.Sc (Agriculture) completed in any discipline with at least 50% marks in aggregate from a recognized Board/Institution. Candidates awaiting their final results may also apply and must upload a self-undertaking stating that they will furnish the required certificate to the institute at the time of the personal interview.

### **Selection Procedure:**

The short listed candidates will have to appear for further screening on the basis of Group Discussion and Personal Interview at DNS-RICM on specified date(s).

### **Number of Seats and reservation policy:**

The intake capacity for the BBA (Agri-business) is sixty(60) only. Seats for OBC, SC and ST candidates are reserved as per the reservation policy of the Central Government.

### Admission Procedure:

The Application Form and Prospectus can be downloaded from the DNS-RICM website (<https://dnsricmpatna.org>). Alternatively, candidates may obtain them from the Institute upon payment of a non-refundable processing fee of Rs. 500. The fee may be paid either through a Demand Draft drawn in favour of “**Director, D.N.S. Regional Institute of Cooperative Management, Patna,**” payable at Patna, or through digital modes such as RTGS/NEFT/IMPS to the Institute’s account (A/C No.: 30923505568, IFSC: SBIN0004386, Bank: SBI, Patel Nagar, Patna). The duly filled Application Form, along with self-attested photocopies of all required documents and proof of fee payment, must be submitted within the prescribed time. Applications with fees paid through any mode other than those specified above will not be accepted.

The Application Form, complete in all respects, along with the following documents, should reach on or before 30-05-2026 to the Director, D.N.S. Regional Institute of Cooperative Management, Shastri Nagar, Patna – 800023, by Registered/Speed Post only. Applications received late or incomplete in any respect shall be rejected.

### Verification of Documents:

At the time of Group Discussion/PI, candidates will be required to produce all original certificates including mark sheets right from Class X till their eligibility qualifications along with a character certificate from the Head of the Institution (Registrar/ Dean/ Principal/ Director of the University/College/ Institute) last attended.



### Admission Criteria for MBA (Agri-Business):

The candidates will be selected for admission on the basis of their performance in CAT/ CMAT/MAT/XAT/ICAR followed by Group Discussion and Personal Interview. The weightage of these four components will be:

### Admission Criteria for BBA (Agri-Business):

The candidates will be selected for admission on the basis of their performance in Group Discussion and Personal Interview. The weightage of these three components will be:

**Note:** Admission fee, University registration fee, examination fee, development fee, placement assistance charges, etc., shall be borne by the students of MBA (ABM) and BBA (ABM) as per norms. The library security fee (refundable) of ₹5,000/- at the time of admission shall also be borne by the students.



**Refund of Fee:**

If the candidate fails to register within the stipulated period after document verification, his/her admission will stand cancelled automatically and the seat allotted to him/her will automatically be cancelled. The Fee deposited by the candidate will be refunded as per University/Institute rules. The Programme Fee component of the total Fee deposited by the candidate will be refunded only if the student withdraws his/ her admission at least 15 days prior to the formally notified last date of admission. After the mentioned period the programme fee will not be refunded.

**Award of the degree:**

The **MBA (Agri-Business) and BBA (Agri-Business) degrees shall be awarded** to eligible students by “**Tribhuvan Sahkari University**”, Anand (Gujarat) an Institution of National Importance under Ministry of Cooperation, Government of India.

**Placement Assistance:**

The Institute provides comprehensive placement assistance to students upon completion of their MBA/BBA (Agribusiness) programmes. This includes career counselling, industry-interactive sessions, resume building, interview preparation, and skill development programmes to enhance employability. Students are connected with leading agribusiness companies, agri-tech firms, FMCG organizations, cooperatives, rural development institutions, and banks through campus recruitment drives and industry networks. The Placement Cell, supported by the Student Placement Committee, actively assists students in securing opportunities across domains such as agri-inputs, supply chain management, marketing, finance, and agri-entrepreneurship, thereby ensuring a smooth transition from academics to professional careers.

## INSTRUCTIONS

1. The application form must be complete in all respect. Incomplete applications are liable to be rejected.
2. There should be no cuttings and over-writing on the form of application and all entries must be made by the candidate himself/her self legibly. The columns not applicable to a particular candidate should fill “NA” in that column.
3. The applicant should fully ensure before dispatching the application whether he/she fulfills the eligibility requirements programme, as the application fee once paid shall not be refunded in the event of rejection of the application.
4. The Committee reserves the right to refuse the admission of any candidate despite fulfilling admission criteria, for reason(s) to be recorded in writing. In all matters relating to admission, decision of Admission Committee/Board shall be final. The decision of the Committee shall be final and legally binding on the candidate.
